- b. encouraged respect for the American constitutional system and the rule of law; and
- c. helped forward the discussion and debate of constitutional issues by the public and/or the profession.

Eligibility – a citizen residing in the State of North Carolina.

Nomination Process –

1. Nominations are solicited by email distributed to N.C. Bar Association members by November 1 of each year. A nomination may be made by any member in good standing of the N.C. Bar Association.
2. The award selection shall be made by the Nominations Committee of the Executive Council of the Constitutional Law Section of the N. C. Bar Association.
3. The award will be presented at the annual meeting of the Constitutional Rights and Responsibilities Law Section.
