

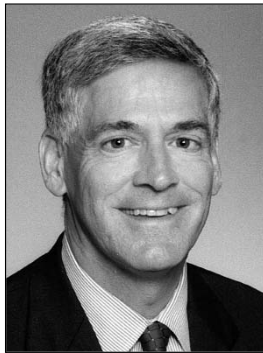
Benjamin R. Kuhn

G. Gray Wilson

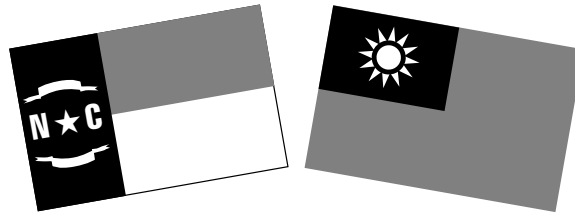

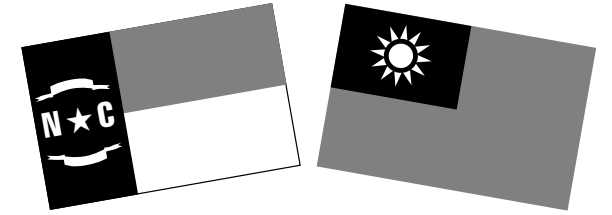
