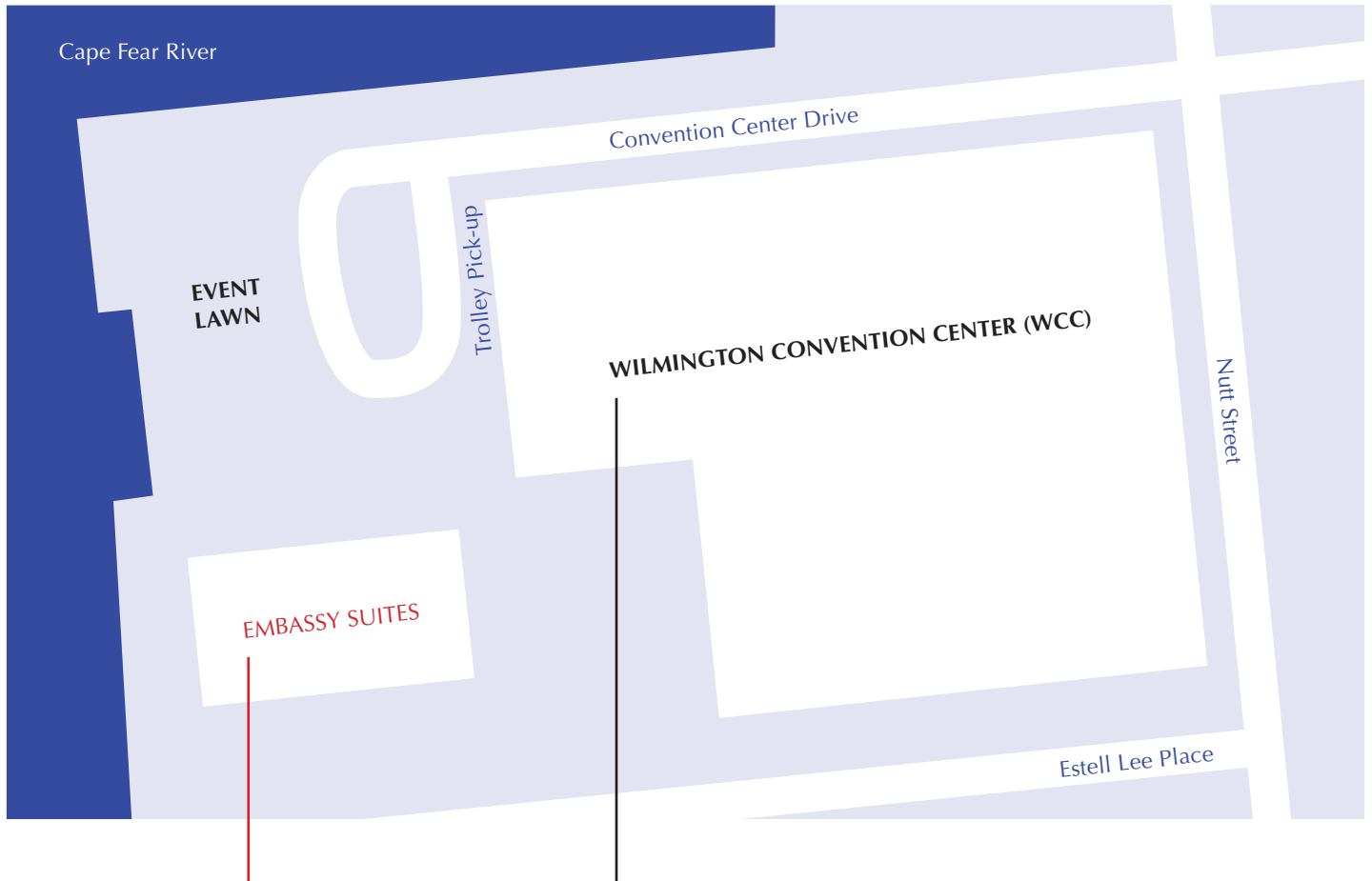

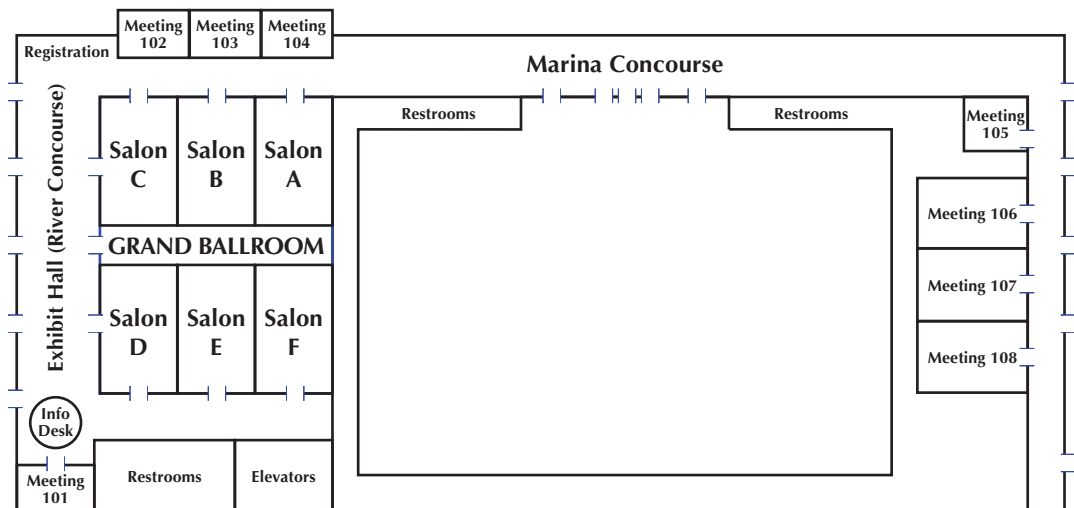

MARK MARTIN has served on the Supreme Court of North Carolina since 1999 and has served as Chief Justice since Sept. 1, 2014. Martin is the only active member of the North Carolina state judiciary with experience on the Supreme Court, Court of Appeals, and Superior Court. He is a past chair of the ABA Judicial Division and a former NCBA vice president. Martin is a graduate of Western Carolina University and the University of North Carolina School of Law, and he has an LL.M. in Judicial Process from the University of Virginia. He has taught at the UNC School of Law, NCCU School of Law, and Duke University School of Law. Martin currently serves on the Committee on Federal-State Jurisdiction of the Judicial Conference of the United States.

JUDGE CARL R. FOX has served on the Superior Court bench since 2005 and is a former district attorney and assistant district attorney in Prosecutorial District 15B. His inspiring life and career includes a widely documented battle with myelodysplastic syndrome, often referred to as “bone marrow failure disorder.” Diagnosed in 2015 at the age of 62, Fox ultimately underwent a successful cord blood transplant and was back in the courtroom a year later. Fox has received numerous awards and served on multiple boards and commissions, including Ronald McDonald House, SECU Family House of Chapel Hill, the Chief Justice’s Commission on Professionalism and the N.C. Courts Commission.
